As EU Parliament rapporteur in charge of the report on the guidance for reform needs on professional services, I had the opportunity to meet and discuss with many representatives of professional organizations, including CEPI. On the occasion of the debate on the amendments to my report in the Internal Market and Consumer Protection Committee, it was my pleasure to invite CEPI delegates and allow them to experience the proceedings of the European Parliament on this important dossier.

I believe that such contacts provide invaluable information and precious exchanges for all the actors concerned. I look forward to continuing this kind of fruitful working relationship in the years to come.

I am strongly convinced that the EU should preserve the high-quality of professional services in Europe and should promote an effective regulatory environment for EU professionals.

CEPI'S YEAR IN A FLASH

2017 was a busy and varied year for CEPI. Some of the highlights included:

Beginning the year at the Vienna Real Estate Ball in February 2017. Combined with an Extraordinary General Meeting (EGM) including meetings of the Board of Directors, Professional Divisions CEAB and PAC as well as a policy meeting this brought delegates together in the elegant environment of the Hofburg Palace.

2017 saw more work on the implementation of the European Professional Card (EPC). On May 6 CEPI President Luc Machon represented the association as a panel member at a workshop in Brussels to discuss progress following the first year of its implementation for the first five professions.


The European Commission continued to focus on the real estate professions in the context of professional qualifications and regulations, publishing the Services Package in January 2017 including guidance for reform needs directly affecting real estate agents. CEPI engaged in a series of discussions and published a position paper in May 2017 together with a follow-up statement in October 2017.

The second EGM of the year saw CEPI delegates travel to Brussels in October 2017. As well as participating in the EGM and associated meetings of the Board, Professional Divisions and PTCs, this gave them the chance to visit the European Parliament as part of the programme for CEPI's Brussels Day which coincided with the debate in the Internal Market and Consumer Protection (IMCO) Committee on amendments to the report on professional regulation prepared by rapporteur Nicola Danti MEP. Delegates also benefited from individual sessions with MEPs and their national permanent representations in Brussels.

The rules on anti-money laundering and related legislation continued to be a concern for CEPI and its member associations. CEPI met with the European Commission to discuss progress concerning its supranational risk assessment for the real estate sector and provided feedback on its report.

The Secretariat continued its work on the transition of CEPI-CEI to CEPI following the merger of the two associations in 2015 and the transition period of one year and a half resulting in a newly formed association with a new President and Board of Directors. New tools and activities are being developed for the new look CEPI.
